A BILL FOR AN ACT

RELATING TO APPRENTICESHIPS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that apprenticeship
- 2 programs are age-old, successful models for developing skilled
- 3 workers. Apprenticeship programs approved by University of
- 4 Hawaii community colleges are composed of two major components:
- 5 work process and related instruction. The work process
- 6 component consists of on-the-job training, while the related
- 7 instruction component is the structured class and laboratory or
- 8 shop curricula. Therefore, apprenticeship programs develop job
- 9 skills through both theoretical and practical experiences.
- 10 Furthermore, upon completion of an approved apprenticeship
- 11 program, work process and related instruction hours may be
- 12 applied toward an associate degree.
- 13 The legislature also finds that in 2016, the United States
- 14 Department of Labor, Employment and Training Administration,
- 15 awarded the department of labor and industrial relations a
- 16 \$1,167,291 grant to expand apprenticeship opportunities in
- 17 information technology and health care. This grant helped to

- 1 alleviate the shortage of physicians, pharmacy technicians,
- 2 nursing assistants, paraoptometric technicians, medical
- 3 laboratory workers, and community health workers.
- 4 Research and peer reviewed studies focusing on the role of
- 5 community health workers have overwhelmingly documented the
- 6 positive impact of community health workers in improving chronic
- 7 disease outcomes and lowering health care costs. In addition,
- 8 community health workers increasingly provide services that help
- 9 reduce the number of homeless individuals in Hawaii.
- 10 The purpose of this Act is to provide funding to continue
- 11 and expand health care apprenticeship programs at the University
- 12 of Hawaii community colleges.
- 13 SECTION 2. There is appropriated out of the general
- 14 revenues of the State of Hawaii the sum of \$ or so
- 15 much thereof as may be necessary for fiscal year 2019-2020 and
- 16 the same sum or so much thereof as may be necessary for fiscal
- 17 year 2020-2021 for health care apprenticeship programs at
- 18 community colleges.
- 19 The sums appropriated shall be expended by the University
- 20 of Hawaii for the purposes of this Act.
