The report shall contain findings 13 and recommendations, including any proposed legislation, for continuation, modification, or termination of the pilot program. 14 15 The department of human services shall submit the report to the 16 legislature no later than twenty days prior to the convening of 17 the regular session of [2019.] 2020."
