# A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF HUMAN SERVICES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to provide funding
- 2 for the operations and capital improvement projects of the
- 3 department of human services for the fiscal biennium beginning
- 4 July 1, 2019, and ending June 30, 2021.
- 5 SECTION 2. The following sums, or so much thereof as may
- 6 be sufficient to accomplish the purposes and programs designated
- 7 herein, are hereby appropriated or authorized, as the case may
- 8 be, from the means of financing specified to the department of
- 9 human services for the fiscal biennium beginning July 1, 2019,
- 10 and ending June 30, 2021. The total expenditures and the number
- 11 of positions in each fiscal year of the biennium shall not
- 12 exceed the sums and the position ceilings indicated for each
- 13 fiscal year, except as provided elsewhere in this Act or as
- 14 provided by general law.

- 10 for the projects separately.
