BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

6	(2)	[Has] Provides a copy of the organization's bylaws or	
7		policies that describe the manner in which the	
8		activities or services for which a grant is awarded	
9		shall be conducted or provided $[-]_{\underline{i}}$	
10	(3)	Provides a current certificate of good standing from	
11		the department of commerce and consumer affairs;	
12	(4)	Provides a current tax clearance from the department	
13		of taxation; and	
14	(5)	Provides proof that the organization is current in the	
15		payment of real property taxes, if applicable to the	
16		organization.

1	(c)	Further, a grant may be awarded to a nonprofit	
2	organization only if the organization:		
3	(1)	[Has been determined and designated to be a nonprofit	
4		organization by] Provides a copy of its exemption	
5		ruling from the Internal Revenue Service[; and] <u>that</u>	
6		the organization has been granted tax exempt status	
7	n	under section 501(c)(3) of the Internal Revenue Code	
8		and proof that the organization currently maintains	
9		that status;	
10	(2)	Has a governing board whose members have no material	
11		conflict of interest and serve without	
12		compensation[-];	
13	(3)	Provides proof of compliance with section 467B-2.1, if	
14		applicable to the organization; and	
15	(4)	Provides copies of its Form 990, 990-EZ, or 990-N
