A BILL FOR AN ACT

RELATING TO HEALTH CARE PRACTITIONERS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that an estimated one in 2 five hundred children in the State are born with orofacial 3 anomalies, such as cleft lip or cleft palate. The legislature further finds that orthodontic services, such as reconstructive 4 surgery, can assist individuals with orofacial anomalies by 5 addressing functional deficiencies in chewing, swallowing, 6 7 respiration, and speech, as well as unstable or malpositioned oral structures, premature tooth loss, and other health 8 9 In response to individuals and families who lacked problems. 10 access to orthodontic treatment of orofacial anomalies, Act 213, 11 Session Laws of Hawaii 2015 (Act 213), was enacted to require 12 health insurance coverage of medically necessary orthodontic 13 services for the treatment of certain orofacial anomalies. Under the definition of "orthodontic services" in Act 213, the 14 services are required to be provided by a licensed dentist with 15 a certification in orthodontics by the American Board of 16 17 Orthodontics (ABO).

1 However, the legislature notes that of the approximately 2 forty orthodontists in the State, only fourteen are certified by 3 the ABO. Furthermore, of the fourteen orthodontists with an ABO 4 certification, only a few have performed the medically necessary 5 orthodontic services for treatment of orofacial anomalies 6 described in sections 431:10A-132 and 432:1-613, Hawaii Revised 7 Statutes, and only in limited circumstances. The legislature 8 also notes that a certification by the ABO is voluntary and not 9 required to practice orthodontics in the State.

10 The purpose of this Act is to expand the pool of 11 orthodontists who are eligible to perform orthodontic services 12 for treatment of orofacial anomalies, covered by health 13 insurance, to any licensed dentist who has completed an 14 orthodontic residency program.

15 SECTION 2. Section 431:10A-132, Hawaii Revised Statutes, 16 is amended by amending subsection (h) to read as follows:

17 "(h) As used in this section, unless the context clearly18 requires otherwise:

"Orofacial anomalies" means cleft lip or cleft palate and
other birth defects of the mouth and face affecting functions
such as eating, chewing, speech, and respiration.



Statutory material to be repealed is bracketed 8 and stricken. New statutory material is underscored. 9 This Act shall take effect upon its approval. 10 SECTION 5.
