A BILL FOR AN ACT

RELATING TO FIREARMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the Terrorist
- 2 Screening Database, informally referred to as the terrorist
- 3 watchlist, was established under President George W. Bush in
- 4 2003 as a response to the September 11, 2001, attacks. Several
- 5 different federal agencies can submit information to the
- 6 watchlist which is administered by the Federal Bureau of
- 7 Investigation's Terrorist Screening Center. Individuals are
- 8 placed on the watchlist when there is reasonable suspicion that
- 9 they are known or suspected terrorists.
- 10 According to the United States Government Accountability
- 11 Office, individuals on the watchlist attempted to purchase
- 12 firearms from United States dealers at least 2,233 times and
- 13 succeeded ninety-one per cent of the time. The legislature
- 14 concludes that inclusion on the Federal Bureau of
- 15 Investigation's Terrorist Screening Database indicates that an
- 16 individual poses a serious and potentially threatening risk to
- 17 public safety. At least two other states have implemented, and

- 1 several others are considering, prohibitions on firearms
- 2 ownership by individuals on the watchlist.
- 3 The purpose of this Act is to include notification to the
- 4 Terrorist Screening Center of the Federal Bureau of
- 5 Investigation to Hawaii's gun permit background check process.
- 6 SECTION 2. Section 134-2, Hawaii Revised Statutes, is
- 7 amended by amending subsection (e) to read as follows:
- 8 "(e) The permit application form shall be signed by the
- 9 applicant and by the issuing authority. One copy of the permit
- 10 shall be retained by the issuing authority as a permanent
- 11 official record. Except for sales to dealers licensed under
- 12 section 134-31, or dealers licensed by the United States
- 13 Department of Justice, or law enforcement officers, or where a
- 14 license is granted under section 134-9, or where any firearm is
- 15 registered pursuant to section 134-3(a), no permit shall be
- 16 issued to an applicant earlier than fourteen calendar days after
- 17 the date of the application; provided that a permit shall be
- 18 issued or the application denied before the twentieth day from
- 19 the date of application. Permits issued to acquire any pistol
- 20 or revolver shall be void unless used within ten days after the
- 21 date of issue. Permits to acquire a pistol or revolver shall

- 1 require a separate application and permit for each transaction.
- 2 Permits issued to acquire any rifle or shotgun shall entitle the
- 3 permittee to make subsequent purchases of rifles or shotguns for
- 4 a period of one year from the date of issue without a separate
- 5 application and permit for each acquisition, subject to the
- 6 disqualifications under section 134-7 and subject to revocation
- 7 under section 134-13; provided that if a permittee is arrested
- 8 for committing a felony or any crime of violence or for the
- 9 illegal sale of any drug, the permit shall be impounded and
- 10 shall be surrendered to the issuing authority. The issuing
- 11 authority shall perform an inquiry on an applicant by using the
- 12 International Justice and Public Safety Network, including the
- 13 United States Immigration and Customs Enforcement query, the
- 14 National Crime Information Center, and the National Instant
- 15 Criminal Background Check System, pursuant to section 846-2.7,
- 16 and shall inform the Federal Bureau of Investigation's Terrorist
- 17 Screening Center of the application, before any determination to
- 18 issue a permit or to deny an application is made."
- 19 SECTION 3. New statutory material is underscored.
