A BILL FOR AN ACT

RELATING TO THE PENAL CODE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds that objects, such as SECTION 1. 2 tents and other illegal structures, that obstruct public 3 sidewalks are increasingly being anchored or attached to 4 adjacent property, such as fences belonging to private owners. 5 The legislature further finds that existing law does not appear to empower law enforcement officers to summarily detach these 6 7 objects from the private property. Complaints about objects 8 attached to fences or other structures are likely to be treated 9 as civil complaints that property owners must initiate through 10 the courts.

11 The purpose of this Act is to prevent the attachment of 12 objects to fences and other structures without permission, and 13 facilitate the removal of objects attached in this manner, by 14 establishing the criminal offense of unauthorized attachment of 15 an object to a fence, gate, or wall.

11	without delay or notice. The owner shall not be subject to

13	any damages that may result from the owner's gross negligence or
14	wanton acts or omissions. A law enforcement officer, at the
15	request of the owner, may also detach the object without delay
16	or notice. Removal of the object may be conducted at the law
17	enforcement officer's discretion, pursuant to state law or
18	county ordinance that authorizes the removal.
19	(3) Unauthorized attachment of an object to a fence, gate,
20	or wall is a violation; provided that a second or subsequent

2	same offense is a petty misdemeanor.
3	(4) For purposes of this section, "owner" means:

7	real property on which the fence, gate, wall, or other
8	structure or barrier is situated, or their respective
9	assigns or successors in interest."
