1 SECTION 1. The legislature finds that, although the most 2 recent performance audit of the department of public safety was 3 in 2017, its scope was limited to use of special funds, 4 revolving funds, trust funds, and trust accounts. The 5 legislature further finds that no comprehensive audit of the 6 department of public safety's offices, policies, and programs 7 has been performed in recent history. The purpose of this Act 8 is to require a comprehensive performance audit of the 9 department of public safety. 10 SECTION 2. (a) The auditor shall conduct a performance 11 audit of the following offices and programs within the 12 department of public safety: 13 (1)The office of the director; 14 (2)The civil rights compliance office; 15 (3) The personnel management office; 16 (4) The fiscal office; and
