A BILL FOR AN ACT

RELATING TO PUBLIC SAFETY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that, although the most
- 2 recent performance audit of the department of public safety was
- 3 in 2017, its scope was limited to a review of the department's
- 4 special funds, revolving funds, trust funds, and trust accounts.
- 5 The legislature further finds that no comprehensive audit of the
- 6 department of public safety's offices, policies, and programs
- 7 has been performed in recent history. The purpose of this Act
- 8 is to require a comprehensive performance audit of the
- 9 department of public safety.
- 10 SECTION 2. (a) The auditor shall conduct a performance
- 11 audit of the following offices and programs within the
- 12 department of public safety:
- 13 (1) The office of the director;
- 14 (2) The civil rights compliance office;
- 15 (3) The personnel management office;
- 16 (4) The fiscal office; and
- 17 (5) The health care division's mental health services.

1	(4) The ability of the department to provide necessary		
2	mental health services to inmates and pre-trial		
3	detainees, including whether the department is taking		
4	adequate steps to fill staffing vacancies related to		
5	the provision of mental health services.		
6	SECTION 3. The auditor shall submit a report on the		
7	performance audit, including the auditor's findings,		
8	recommendations, and proposed legislation, if necessary, to the		
9	legislature no later than twenty days prior to the convening of		
10	the regular session of 2021.		
11	SECTION 4. There is appropriated out of the general		
12	revenues of the State of Hawaii the sum of \$ or so much		
13	thereof as may be necessary for fiscal year 2019-2020 for the		
14	auditor to conduct a performance audit of the department of		
15	public safety pursuant to this Act.		
16	The sum appropriated shall be expended by the auditor for		
17	the purposes of this Act.		
18	SECTION 5. This Act shall take effect on July 1, 2050.
