### A BILL FOR AN ACT

RELATING TO FIREWORKS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that it is reasonable to 2 allow the use of fireworks with a permit for movie or theatrical productions or for the safe disposal of confiscated fireworks by 3 4 law enforcement agencies. 5 The purpose of this Act is to: 6 (1) Allow the use of fireworks by permit for film or movie productions; and (2) Authorize law enforcement agencies to test, dispose 8 9 of, or destroy illegal, unwanted, or confiscated fireworks. 10 11 SECTION 2. Section 132D-6, Hawaii Revised Statutes, is 12 amended to read as follows:
