A BILL FOR AN ACT

RELATING TO KEKAHA KAI STATE PARK.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that lifeguards act as
- 2 the primary responders for emergencies on shorelines and within
- 3 nearshore waters, where the majority of ocean recreation
- 4 activity takes place. Lifeguards also provide injury control
- 5 and dispatch ocean rescue services. Moreover, the legislature
- 6 also finds that although Kua Bay, Kekaha Kai state park (Kua
- 7 Bay) in North Kona on the island of Hawaii is under the
- 8 jurisdiction of the department of land and natural resources,
- 9 the State currently does not employ its own lifequards at Kua
- 10 Bay.
- 11 The legislature further finds that the location of Kua Bay
- 12 between Kona and the resorts of Kohala Coast and improvements to
- 13 Kekaha Kai state park, such as a paved road and comfort station,
- 14 have led to an increase in visits by locals and tourists, making
- 15 Kua Bay one of the most popular beaches in the State.
- 16 Consequently, the increase in visitation is accompanied by an

- 1 increase in dangerous incidents, injuries, and deaths, which
- 2 could be mitigated by placement of lifeguards at Kua Bay.
- 3 From 2013 to 2016, emergency medical service patient care
- 4 reported twenty-eight calls from the Kua Bay area, fourteen
- 5 alone from 2016, with nineteen of the calls resulting in
- 6 hospitalization for a traumatic injury. Additionally, the
- 7 Hawaii Trauma Registry reports that there were seven spinal cord
- 8 injuries from 2009 to 2013. According to the department of
- 9 health's emergency medical services and injury prevention system
- 10 branch's GIS database of fatal drownings, three people have
- 11 drowned in the Kua Bay area since 2013.
- 12 The purpose of this Act is to save lives and prevent injury
- 13 at Kua Bay by appropriating funds for the employment of
- 14 lifequards and for necessary equipment.
- 15 SECTION 2. There is appropriated out of the general
- 16 revenues of the State of Hawaii the sum of \$400,000 or so much
- 17 thereof as may be necessary for fiscal year 2019-2020 and the
- 18 same sum or so much thereof as may be necessary for fiscal year
- 19 2020-2021 for the establishment of four full time equivalent
- 20 (4.0 FTE) permanent ocean safety officers for Manini'ōwali beach
- 21 at Kua bay in the Kekaha Kai state park on the island of Hawaii;

- 1 provided that the county of Hawaii shall hire and provide
- 2 benefits for the four full-time equivalent (4.0 FTE) permanent
- 3 ocean safety officer positions established pursuant to this Act.
- 4 The sums appropriated shall be expended by the department
- 5 of land and natural resources for the purposes of this Act.
- 6 SECTION 3. There is appropriated out of the general
- 7 revenues of the State of Hawaii the sum of \$80,000 or so much
- 8 thereof as may be necessary for fiscal year 2019-2020 for the
- 9 department of land and natural resources to purchase equipment
- 10 to be used by state ocean safety officers in the course of their
- 11 work at Manini'ōwali beach at Kua Bay in the Kekaha Kai state
- 12 park on the island of Hawaii; provided that the sum appropriated
- 13 shall be expended as follows:
- (1) \$60,000 for one lifeguard tower;
- 15 (2) \$8,000 for one all-terrain vehicle;
- 16 (3) \$8,000 for radios;
- 17 (4) \$3,000 for rescue equipment; and
- 18 (5) \$1,000 for protective equipment.
- 19 The sum appropriated shall be expended by the department of
- 20 land and natural resources for the purposes of this Act.

1 SECTION 4. This Act shall take effect on July 1, 2019.
