### A BILL FOR AN ACT

RELATING TO EMOTIONAL SUPPORT ANIMALS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 347-2.5, Hawaii Revised Statutes, is
amended to read as follows:

"§347-2.5 Service dog, defined. As used in this chapter, 3 4 "service dog" means any dog that is individually trained to do 5 work or perform tasks for the benefit of an individual [with] who is certified in writing by a doctor to have a disability, 6 including a physical, sensory, intellectual, or other mental 7 disability[. A companion or comfort animal is not a service dog 8 9 unless it meets the requirements of this definition and it accompanies a person for the purpose of performing the work or 10 11 tasks for which it has been trained.], including anxiety or any 12 other emotional disorder." 13 SECTION 2. Section 347-13, Hawaii Revised Statutes, is 14 amended to read as follows: 15 "§347-13 Persons who are blind, visually handicapped, disabled; public places; public conveyances. (a) Persons who 16

are blind, visually handicapped, or otherwise disabled are

1 entitled to full and equal accommodations, advantages, 2 facilities, and privileges of all common carriers, airplanes, motor vehicles, railroad trains, motor buses, street cars, 3 4 boats, or any other public conveyances or modes of 5 transportation, hotels, lodging places, places of public accommodation, amusement, or resort, and other places to which 6 7 the general public is invited, subject only to the conditions 8 and limitations established by law and applicable to all 9 persons.

10 Every person who is blind, deaf, visually handicapped, (b) 11 or otherwise disabled shall have the right to be accompanied by a service animal, especially trained for the purpose of 12 assisting the person, or an emotional support animal, in any of 13 the places listed in subsection (a) without being required to 14 15 pay an extra charge for the service animal [+] or emotional 16 support; provided that the person shall be liable for any damage 17 done to the premises or facilities by the service animal [-] or 18 emotional support animal. No service animal or emotional 19 support animal shall be considered dangerous merely because it 20 is unmuzzled.

1	(c) Every disabled person shall have the right to use a
2	life jacket or other flotation device in a public swimming pool;
3	provided that:
4	(1) The person suffers from a physical disability or
5	condition that requires the use of a life jacket or
6	other flotation device; and
7	(2) The person obtains a statement signed by a licensed
8	physician, physician assistant, or advanced practice
9	registered nurse attesting to the person's need to use
10	a life jacket or other flotation device.
11	(d) The director of human services shall adopt rules
12	pursuant to chapter 91 necessary for the purposes of this
13	section.
14	(e) For the purposes of this section, "emotional support
15	animal" means any animal that a licensed medical professional
16	has determined provides therapeutic benefit for an individual
17	with a disability, including anxiety or any other emotional
18	disorder, and for which the licensed medical professional has
19	provided written certification stating the professional's
20	determination."

SECTION 3. This Act does not affect rights and duties that
matured, penalties that were incurred, and proceedings that were
begun before its effective date.

4 SECTION 4. Statutory material to be repealed is bracketed 5 and stricken. New statutory material is underscored.

6 SECTION 5. This Act shall take effect upon its approval.
