SECTION 1. There is appropriated out of the general
 revenues of the State of Hawaii the sum of \$2,565,469 or so much
 thereof as may be necessary for fiscal year 2019-2020 and the
 sum of \$1,772,998 for fiscal year 2020-2021 or so much thereof
 as may be necessary for the disability compensation division
 modernization project (LBR183/DA).

7 The sums appropriated shall be expended by the department 8 of labor and industrial relations for the purpose of this Act. 9 SECTION 2. There is appropriated out of the general 10 revenues of the State of Hawaii the sum of \$225,000 or so much 11 thereof as may be necessary for fiscal year 2019-2020 and the 12 same sum or so much thereof as may be necessary for fiscal year 13 2020-2021 for the independent verification and validation of the 14 disability compensation division modernization project 15 (LBR183/DA).

16 The sums appropriated shall be expended by the department17 of labor and industrial relations for the purpose of this Act.
