## A BILL FOR AN ACT

RELATING TO THE LAND CONSERVATION FUND.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 173A-5, Hawaii Revised Statutes, is 1 2 amended by amending subsection (h) to read as follows: 3 "(h) The fund shall be used for: The acquisition of interests or rights in land having 4 (1)5 value as a resource to the State, whether in fee title or through the establishment of permanent conservation 6 easements under chapter 198 or agricultural easements; 7 8 (2)The payment of any debt service on state financial 9 instruments relating to the acquisition of interests 10 or rights in land having value as a resource to the 11 State; 12 (3) Annual administration costs for the fund, not to 13 exceed five per cent of annual fund revenues of the 14 previous year[+]; and[+] 15 Costs related to the operation, maintenance, and (4)

Section 247-7, Hawaii Revised Statutes, is 7 8 amended to read as follows: "§247-7 Disposition of taxes. All taxes collected under 9 this chapter shall be paid into the state treasury to the credit 10 of the general fund of the State, to be used and expended for 11 the purposes for which the general fund was created and exists 12 by law; provided that of the taxes collected each fiscal year: 13 Ten per cent or [<del>\$6,800,000,</del>] \$8,800,000, whichever is 14 (1)less, shall be paid into the land conservation fund 15 established pursuant to section 173A-5; and 16 (2) Fifty per cent or \$38,000,000, whichever is less, 17 shall be paid into the rental housing revolving fund 18 established by section 201H-202." 19 SECTION 3. There is appropriated out of the land 20 conservation fund the sum of \$7,482,115 or so much thereof as 21
