A BILL FOR AN ACT

RELATING TO HOUSING ON HAWAIIAN HOME LANDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 214, Hawaiian Homes Commission Act,
 1920, as amended, is amended by amending subsection (a) to read
 as follows:

"(a) The department may make loans from revolving funds to
any lessee or native Hawaiian to whom, or any cooperative
association to which, a lease has been issued under section
207(a) of this Act or a license has been issued under section
207(c)(1)(B) of this Act. Such loans may be made for the
following purposes:

10 (1) The repair or maintenance or purchase or erection of
11 dwellings on any tract, and the undertaking of other
12 permanent improvements thereon;

13 (2) The purchase of livestock, swine, poultry, fowl,
14 aquaculture stock, and farm and aquaculture equipment;
15 (3) Otherwise assisting in the development of tracts and
16 of farm, ranch, and aquaculture operations, including:

13	necessary for fiscal year 2020-2021 for the construction of
14	micro housing units as defined in section 107- , Hawaii Revised
15	Statutes, to be matched on a dollar-for-dollar basis by funds
16	awarded through the Native Community Development Financial
17	Institutions Program; provided that:
18	(1) The cost of construction of each micro housing unit
19	shall not exceed \$125,000;
20	(2) A micro housing unit may be constructed on an existing
21	homestead lot upon which a home already exists;

1 SECTION 4. The provisions of the amendments made by this 2 Act to the Hawaiian Homes Commission Act, 1920, as amended, are 3 declared to be severable, and if any section, sentence, clause, 4 or phrase, or the application thereof to any person or 5 circumstances is held ineffective because there is a requirement 6 of having the consent of the United States to take effect, then 7 that portion only shall take effect upon the granting of consent 8 by the United States and effectiveness of the remainder of these 9 amendments or the application thereof shall not be affected. 10 SECTION 5. Statutory material to be repealed is bracketed 11 and stricken. New statutory material is underscored. 12 SECTION 6. This Act shall take effect on July 1, 2019; 13 provided that section 1 shall take effect with the consent of 14 the United States Congress.

Makes appropriations from the Department of Hawaiian Home Lands' vacancy savings to the Department of Hawaiian Home Lands for construction of micro housing units, subject to certain conditions, and to build general organizational capacity of native Hawaiian-controlled nonprofit housing developers.
