A BILL FOR AN ACT

RELATING TO WATER.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the board of land 2 and natural resources lacks rules for rendering decisions on 3 land dispositions that authorize water diversion from streams. The legislature believes that public trust principles must guide 4 5 these decisions and must supersede commercial interests and that 6 the impacts of climate change are not sufficiently clear to allow for any disposition lasting more than fifteen years. 7 The purpose of this Act is to: 8 9 Prohibit the board of land and natural resources from (1) approving dispositions that authorize the diversion of 10 11 water from streams, except under specified 12 circumstances; and 13 Require moneys collected through land dispositions (2) 14
 - that authorize the diversion of water from streams to be deposited into the forest stewardship fund.

1	SECTION 2. Chapter 171, Hawaii Revised Statutes, is	
2	amended by adding a new section to be appropriately designated	
3	and to read as follows:	
4	"§171- Dispositions that authorize the diversion of	
5	water from streams. (a) The board shall not approve a	
6	disposition	on that authorizes or has the effect of authorizing the
7	diversion	of water from a stream unless:
8	(1)	The authorization is for no more than fifteen years;
9	(2)	The board has accurate information as to how much
10		water flows in a stream and how much water is proposed
11		to be diverted from it;
12	(3)	The fee charged is at least ninety per cent of the
13		avoided cost to the applicant of obtaining the water
14		<pre>from an alternative source;</pre>
15	(4)	At all times no more than half of the water in a
16		stream is diverted from the stream;
17	(5)	The board concludes that the diversion will not
18		adversely impact the ecological, cultural,
19		recreational, and aesthetic values of the stream; and
20	(6)	All other legal requirements are met.

- 1 (b) Moneys collected through any land disposition that
- 2 authorizes or has the effect of authorizing the diversion of
- 3 water from a stream shall be deposited into the forest
- 4 stewardship fund established pursuant to section 195F-4;
- 5 provided that the department of Hawaiian home lands and the
- 6 office of Hawaiian affairs shall receive their respective
- 7 constitutionally-entitled shares."
- 8 SECTION 3. New statutory material is underscored.
- 9 SECTION 4. This Act shall take effect upon its approval.
