# A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII BOARD OF REGENTS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that the composition and
 term limits of members of the board of regents of the University
 of Hawaii is a matter of statewide concern that falls under its
 purview pursuant to article X, section 6, of the Hawaii State
 Constitution

6 The purpose of this Act is to amend the composition and
7 term length of the members of the board of regents of the
8 University of Hawaii.

9 SECTION 2. Section 26-11, Hawaii Revised Statutes, is
10 amended by amending subsection (a) to read as follows:

"(a) The University of Hawaii shall be headed by an
executive board to be known as the board of regents.

13 The board shall consist of [fifteen] <u>nine</u> members. At 14 least one member shall be a University of Hawaii student at the 15 time of the initial appointment. [This member may be 16 reappointed for one additional term even though the member may 17 no longer be a student at the time of reappointment.] The

governor shall reduce the terms of those initially appointed to 1 2 each seat on the board of regents to provide, as far as 3 practicable, for the expiration of three terms each year; 4 provided that the term of the student member shall not be 5 reduced. 6 [At least twelve] The members, except for the student 7 member, shall represent and reside in the specified geographic areas as follows: 8 9 Two members from the county of Hawaii[, ], with one (1) member from east Hawaii and one member from west 10 11 Hawaii; 12 (2) [Two-members] One member from the county of Maui; 13 One member from the county of Kauai; and (3) [Seven] Four members from the city and county of 14 (4)Honolulu [-]; provided that of the four members, two 15 members shall represent and reside in the first 16 17 congressional district of the State and the other two 18 members shall represent and reside in the second 19 congressional district of the State. 20 The student member shall be the student body president, or 21 its equivalent, from one of the various University of Hawaii



1	campuses; provided that this appointment shall rotate every two
2	years among the student body president from the University of
3	Hawaii at Manoa, University of Hawaii at Hilo, or University of
4	Hawaii West-Oahu and the student body president, or its
5	equivalent, from a campus among the University of Hawaii
6	community college system.
7	At least one member shall have demonstrated expertise in
<b>8</b> ·	native Hawaiian traditional and customary practices.
9	The board shall have the power, in accordance with the
10	Hawaii constitution and with law, to formulate policy and to
11	exercise control over the university through its executive
12	officer, the president of the university. The board shall have
13	exclusive jurisdiction over the internal organization and
14	management of the university. The board shall hold the
15	president of the university and university administration
16	accountable for decisions, actions, and leases that incur
17	additional costs to the university."
18	SECTION 3. Section 304A-104, Hawaii Revised Statutes, is
19	amended to read as follows:
20	"§304A-104 Regents; appointment; tenure; qualifications;
21	meetings. (a) The affairs of the university shall be under the

general management and control of the board of regents. The 1 board shall consist of [fifteen] nine members who shall be 2 appointed by the governor from lists of qualified candidates 3 presented to the governor by the candidate advisory council, 4 pursuant to section 304A-104.6, and shall be confirmed by the 5 senate; provided that if the list of qualified candidates 6 includes fewer than three candidates at any time during the 7 8 nomination and confirmation process, the governor may request that the candidate advisory council reopen recruitment for 9 qualified candidates. Members may be removed by the governor. 10 Except as otherwise provided by law, state officers shall be 11 12 eligible for appointment and membership.

The term of each member shall be [five] four years, except 13 as provided for the initial appointment in section 26-11; 14 provided that the term of the student member shall be two years. 15 16 Every member may serve beyond the expiration date of the member's term of appointment as a holdover member until the 17 18 member's successor has been appointed by the governor and confirmed by the senate in accordance with article X, section 6 19 20 of the Hawaii State Constitution [-]; provided that,

21 notwithstanding any law to the contrary, a holdover member shall

1 not serve as a member of the board beyond the end of the first 2 regular legislative session following the expiration of the 3 member's term. Members shall serve no more than two consecutive 4 [five year] four-year terms; provided that the members who are 5 initially appointed to terms of two years or less pursuant to 6 section 26-11(a) may be reappointed to two ensuing [five-year] 7 four-year terms. If a member is to be appointed to a second 8 term of [five] four years, the senate shall consider the 9 question of whether to reconfirm the member at least one hundred 10 twenty days prior to the conclusion of a member's first [five-11 year] four-year term; provided that if the senate is not in 12 session within one hundred twenty days prior to the conclusion of the member's first [five year] four-year term, the member 13 14 shall continue to serve until the senate convenes for the next 15 regular session or the next special session for which the senate 16 is authorized to consider the question of reconfirmation. 17 (b) In determining whether to confirm the governor's

18 nominee to the board of regents, the senate shall consider the 19 combination of abilities, breadth of experiences, and 20 characteristics of the board of regents, as a whole, that will 21 best serve the diverse interests and needs of the students of

1 the university system and assist the university system in
2 achieving its strategic goals and performance indicators. The
3 senate shall consider whether the board reflects the diversity
4 of the student population, the various counties of the State,
5 and a broad representation of higher education-related
6 stakeholders.

7 (C) At its first meeting after June 30 of each year, the 8 board of regents shall elect a chairperson and one or more vice-9 chairpersons who shall serve until the adjournment of the first 10 meeting of the board of regents after June 30 of the next year, 11 or thereafter until their successors are elected; provided that 12 the chairperson and vice chairpersons shall not be elected prior 13 to the taking of office of regents whose terms shall begin on 14 July 1 of that year. The board shall appoint a secretary, who 15 shall not be a member of the board. The president of the 16 university shall act as executive officer of the board. A 17 majority of the board of regents shall constitute a quorum to 18 conduct business, and the concurrence of a majority of all the 19 members to which the board of regents is entitled shall be 20 necessary to make any action of the board of regents valid. The 21 board shall meet at least ten times annually and, from time to



1 time, may meet in each of the counties of Hawaii, Maui, and 2 Kauai.

3 (d) The governor shall notify the candidate advisory
4 council for the board of regents of the University of Hawaii in
5 writing within ten days of receiving notification that a member
6 of the board of regents is resigning or has died, or is being
7 removed by the governor.

8 (e) The members of the board of regents shall serve 9 without pay but shall be entitled to their travel expenses 10 within the State when attending meetings of the board or when 11 actually engaged in business relating to the work of the board. 12 (f) No rule or law shall prohibit discussions between 13 members of the state legislature and one or more members of the 14 board. No board member shall be required to seek permission 15 from any person or agency prior to engaging in any discussion 16 with members of the state legislature."

SECTION 4. Statutory material to be repealed is bracketedand stricken. New statutory material is underscored.

**19** SECTION 5. This Act shall take effect upon its approval.

#### Report Title:

University of Hawaii; Board of Regents; Composition; Terms; Oversight

#### Description:

Amends the composition of the Board of Regents of the University of Hawaii, reduces the number of board members from fifteen members to nine members, and shortens term length from five years to four years. Specifies terms of holdover board members. Specifies that the Board of Regents shall hold the president of the University of Hawaii and university administration accountable for decisions, actions, and leases that incur additional costs to the university. Prohibits any law, rule, or permission requirement related to permitting discussions between a board member and members of the legislature. (SD1)
