### A BILL FOR AN ACT

RELATING TO ENERGY.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the state energy
- 2 office, under the department of business, economic development,
- 3 and tourism, has embarked on a strategic plan to position Hawaii
- 4 as a proving ground for clean energy technologies and accelerate
- 5 the State's agenda to achieve one hundred per cent clean energy
- 6 by the year 2045. The State has embraced bold solutions that
- 7 will help develop the competitive clean energy industry, making
- 8 Hawaii one of the leaders in the clean energy race; however,
- 9 wind turbines are not being placed in areas with the highest
- 10 wind strength and wind source frequency. Additionally,
- 11 placement of some wind turbines adversely impacts wildlife.
- 12 Furthermore, communities that use the least amount of power are
- 13 often the most burdened by the placement of wind turbines.
- 14 Careful, rank-based placement and thoughtful public engagement
- 15 with an emphasis on optimizing coexistence of communities,
- 16 wildlife, and wind turbines will support responsible wind energy
- 17 development.

5	SECTION 2. Section 196-10.5, Hawaii Revised Statutes, is							
6	amended by amending subsection (b) to read as follows:							
7	"(b) Prior to the initiation of any activities authorized							
8	under subsection (a), the department of business, economic							
9	development, and tourism shall develop a plan of action with the							
10	intent of promoting effective prioritization and focusing of							
11	efforts consistent with the State's energy programs and							
12	objectives. For any activities in the plan of action involving							
13	wind energy projects, the department shall give preference to							
14	wind energy project sites based on the following criteria:							
15	(1) Wind source frequency;							
16	(2) Wind strength;							
17	(3) Locations greater than ten miles from existing							
18	generation systems producing more than ten megawatts							
19	of electricity; and							
20	(4) Proximity of the community in demand of additional							
21	power."
