A BILL FOR AN ACT

RELATING TO THE HAWAII TECHNOLOGY DEVELOPMENT CORPORATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that in order to be 2 competitive in a global economy, the State must have a strong, 3 technology-based economic development strategy. The Hawaii 4 technology development corporation and department of business, 5 economic development, and tourism support technology-based 6 economic development, successful outcomes of which include: 7 (1) A research base that generates new knowledge; (2) Mechanisms for transferring knowledge to the 8 9 marketplace; 10 (3) An entrepreneurial culture; 11 (4) Sources of risk capital; and 12 (5) A technically skilled workforce. 13 The legislature also finds that the department of business, economic development, and tourism currently houses many 14 technology-focused programs, such as the Hawaii strategic 15 16 development corporation, Hawaii technology development corporation, Pacific international space center for exploration 17

2 laboratory of Hawaii authority, but these programs are not
3 strategically aligned. In order to improve technology-based

8 SECTION 2. The department of business, economic 9 development, and tourism shall engage a consulting firm pursuant 10 to section 3 of this Act to conduct a study to evaluate the 11 policies and organizational changes needed within the department 12 of business, economic development, and tourism, specifically related to the Hawaii strategic development corporation, Hawaii 13 14 technology development corporation, Pacific international space 15 center for exploration systems, aerospace advisory committee, 16 and natural energy laboratory of Hawaii authority, to enable the 17 State to successfully execute a smart and efficient technology-18 based economic development strategy.

SECTION 3. The department of business, economic

There is appropriated out of the general 6 revenues of the State of Hawaii the sum of \$70,000 or so much 7 thereof as may be necessary for fiscal year 2019-2020 for the department of business, economic development, and tourism to 8 engage a consulting firm to conduct the study pursuant to this 9 10 Act. The sum appropriated shall be expended by the department of 11 12 business, economic development, and tourism for the purposes of

13 this Act.

SECTION 5. This Act shall take effect upon its approval;provided that section 4 shall take effect on July 1, 2019.
