"A BILL FOR AN ACT RELATING TO WIND ENERGY FACILITIES,"

The purpose of this measure is to:

- (1) Establish a setback from the nearest farm dwelling or residential dwelling unit for certain wind energy facilities in the agricultural district; and
- (2) Require the University of Hawaii at Manoa John A. Burns School of Medicine to conduct or contract for a study on the effects of noise produced by certain wind energy facilities in Hawaii on the health of residents and students.
