"A BILL FOR AN ACT RELATING TO THE DEPARTMENT OF HAWAIIAN HOME LANDS, "

beg leave to report as follows:

The purpose of this measure is to appropriate funds for the Department of Hawaiian Home Lands for the acquisition of land in East Oahu to be developed by the Department for affordable housing units to be made available by July 1, 2027.

Your Committees received testimony in support of this measure from the Department of Hawaiian Home Lands. Your Committees received testimony in opposition to this measure from one individual. Your Committees received comments on this measure from one individual.

Your Committees find that this measure supports the Oahu Island Plan adopted by the Hawaiian Homes Commission in July 2014 by appropriating funds to enable the Department of Hawaiian Home Lands to purchase land for development of affordable housing in East Oahu, an area where the Department for Hawaiian Home Lands currently has no landholdings to develop affordable housing units.
