- (1) Establish the Drug Disposal Program, to be administered by the Department of the Attorney General, to dispose of prescription and over-the-counter drugs in a safe, secure, and environmentally friendly manner; and
- (2) Establish the Drug Disposal Special Fund and appropriate funds into and out of the special fund to award grants for the purchase, operation, or maintenance of a drug disposal repository or for the purchase or distribution of home drug disposal receptacles.
