"A BILL FOR AN ACT RELATING TO THE DIVISION OF BOATING AND OCEAN RECREATION,"

The purpose of this measure is to require the State Auditor to conduct a comprehensive performance and management audit of the Department of Land and Natural Resources' Division of Boating and Ocean Recreation.

Your Committee received testimony in support of this measure from Lady Ann Cruises, Inc.; and seven individuals. Your Committee received comments on this measure from the Department of Land and Natural Resources and Office of the Auditor.

Your Committee finds that numerous public concerns have been raised pertaining to the management and performance of the Department of Land and Natural Resources' Division of Boating and Ocean Recreation. Requiring a comprehensive performance and management audit of the division is a step toward improving the efficiency and effectiveness of the division.

Your Committee has amended this measure by changing the effective date to July 1, 2050, to encourage further discussion.
