Your Committee on Finance, to which was referred H.B. No. 2703, H.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO PREVENTING SCHOOL VIOLENCE,"

The purpose of this measure is to help prevent targeted school violence in Hawaii by:

- (1) Establishing a pilot program to establish a start-to-finish response to threats of targeted school violence; and
- (2) Appropriating funds to the Department of Defense for resources to prevent targeted school violence.
