The Civil Beat Law Center for the Public Interest, League of Women Voters of Hawaii, and Hawaii Chapter of the Society of Professional Journalists testified in opposition to this measure. The Office of Information Practices and Hawaii Government Employees Association, AFSCME Local 152, AFL-CIO provided comments.

As affirmed by the record of votes of the members of your Committee on Judiciary that is attached to this report, your Committee is in accord with the intent and purpose of H.B. No. 362, H.D. 1, and recommends that it pass Third Reading.
