The purpose of this measure is to appropriate funds to establish a full-time cardiac catherization laboratory at the Hilo Medical Center.

The Mayor's Office of the County of Hawaii, Hawaii Health Systems Corporation, East Hawaii Region of Hawaii Health Systems Corporation, Hilo Medical Center Foundation, American Heart Association, United Public Workers AFSCME Local 646, AFL-CIO, O'ahu County Committee on Legislative Priorities of the Democratic Party of Hawaii, and many individuals testified in support of this measure.
