Your Committee on Transportation, to which was referred S.B. No. 2103, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO SPECIAL LICENSE PLATES,"

The purpose of this measure is to authorize the issuance of special number electric vehicle license plates to commemorate the Polynesian Voyaging Society (PVS).

Your Committee received testimony in support of this measure from the Ocean Learning Academy, Pacific Islands Institute, Polynesian Voyaging Society, and numerous individuals.

Your Committee finds that the PVS has been influencing and inspiring not only the communities of Hawaii, but also those around the world.
