The purpose of this measure is to clarify certain requirements regarding licensure of child care facilities, including exemptions from licensure, health and safety standards, and investigations of violations.

Your Committee received testimony in support of this measure from the Department of Human Services and one individual.

Your Committee finds that this measure supports the Department of Human Services' enforcement of child care laws in instances when individuals or organizations are providing child care without a license or registration from the Department.

Your Committee has amended this measure by:

(1) Changing the effective date to December 31, 2059, to encourage further discussion; and


(2) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.
