and Natural Resources.


Your Committee finds that Hawaii is the birthplace of  
surfing. Surfing has a strong cultural connection to Hawaii and  
plays a significant role in the history and economy of the State.  
Despite this, many people are unaware of the history and unique  
connection that Hawaii has with surfing. This measure will  
educate the public regarding the history and significance of  
surfing by establishing a State Commission on Surfing.

Your Committee has amended this measure by making technical,  
nonsubstantive amendments for the purposes of clarity and  
consistency.


