<u>SB 2726</u> Status & Testimony	RELATING TO THE DEPOSIT BEVERAGE CONTAINER FEE. Annually adjusts the deposit beverage container fee based upon percentage changes in the Consumer Price Index for the Honolulu area.	AEN, CPH
<u>SB 2727</u> Status & Testimony	RELATING TO DEPOSIT BEVERAGE CONTAINERS. Exempts a beverage dealer who is located in a high density population area from operating a redemption center if the dealer is located within 1 mile of a certified redemption center operated independently of the dealer. <u>SB 2750</u> Status & Testimony	RELATING TO BOTTLED WATER. Repeals the requirement that noncarbonated bottled water be transported, stored, processed, or bottled through lines or equipment through which only water is passed.	AEN, CPH

Establishes the Environmental Council Special Fund; dedicates 0.005 per cent of the Environmental Response, Energy, and Food Security Tax to the Environmental Council Special Fund. Appropriates \$50,000 to the Environmental Council Special Fund from the Environmental Response Revolving fund.	AEN, WAM
<u>SB 2856</u> Status & Testimony	RELATING TO THE BROWNFIELDS CLEANUP REVOLVING LOAN FUND. Enables use of funds for environmental site assessments and for sub-grants to eligible entities for assessment and cleanup of brownfields sites.	AEN, WAM
