SB 2341 RELATING TO PARKING FOR DISABLED PERSONS. HMS, CPH

Status & Testimony

Amends the definitions of "certificate of disability" and "person with a disability" to allow a person with a disability that does not

limit or impair the ability to walk and needs special accommodations to enter and exit their vehicle to be issued a

disability parking permit.

SB 2741 RELATING TO SEX TRAFFICKING. HMS, JDC/WAM

Status & Testimony

Authorizes DHS to establish, or contract with a victim service

provider to operate or manage, an emergency shelter for victims of sex trafficking, subject to available funding. Exempts

compensation received by a victim service provider for operating a sex trafficking emergency shelter from the general excise tax.

SB 2846 RELATING TO SEX TRAFFICKING. HMS, JDC

Status & Testimony Removes the statute of limitations for sex trafficking offenses.

SB 2291 RELATING TO TAXATION. HMS. WAM

Establishes a refundable tax credit equal to an unspecified

percentage of a taxpayer's eligible child care expenses. Defines eligible child care expenses to mean the sum of the taxpayer paid to a child care facility in the State to: (1) support the child care needs of the taxpayer's employees in the taxable year; and (2) purchase child care slots at the child care facility that are actually provided or reserved for children of the taxpayer's employees. Applies to taxable years beginning after December

31, 2019.

SB 2118 RELATING TO DISCRETIONARY TRANSFERS TO THE HMS, JDC

Status & Testimony SUPREME COURT.

Allows child custody appeals to be transferred from the

Intermediate Court of Appeals to the Supreme Court, except in

cases brought under the Child Protective Act.

SB 2119 RELATING TO THE ROOM CONFINEMENT OF CHILDREN AT HMS, JDC

Status & DETENTION AND SHELTER FACILITIES.

Testimony

Limits the circumstances under which children and minors at shelters may be subject to room confinement, and specifies the conditions and time limits for which room confinement may be

nposed.
