HB 2037 RELATING TO THE HAWAII STATE LESBIAN, GAY, HSH, JUD, FIN BISEXUAL, TRANSGENDER, QUEER, PLUS COMMISSION. <u>Status</u> Establishes the Hawaii State Lesbian, Gay, Bisexual, Transgender, Queer, Plus Commission and the Hawaii State Lesbian, Gay, Bisexual, Transgender, Queer, Plus Commission Trust Fund. <u>HB 1978</u> RELATING TO SPECIAL IMMIGRANT JUVENILE STATUS. HSH, JUD, FIN Status Specifies that the family court has jurisdiction in proceedings concerning the custody or guardianship of an immigrant child pursuant to a motion for Special Immigrant Juvenile factual findings requesting a determination that the child was abused, neglected, or abandoned before the age of 18. HB 2067 RELATING TO DOMESTIC VIOLENCE. HSH, JUD, FIN Status Amends the offense of abuse of family or household members to provide for misdemeanor and petty misdemeanor penalties. Allows a deferred acceptance of guilty or no contest plea in misdemeanor and petty misdemeanor abuse penalties. Requires the Judiciary to submit annual reports to the Legislature on the number and outcome of abuse of family or household members cases. Sunsets five years after enactment. RELATING TO PROOF OF DOMESTIC OR SEXUAL VIOLENCE HB 2057 HSH, JUD, FIN Status VICTIM STATUS. Makes consistent the types of documents accepted as proof of domestic or sexual violence victim status. HB 1664 RELATING TO HUMAN SERVICES. HSH, LAB, FIN Status Authorizes the establishment of the Supporting Employment Empowerment Hawaii Work Program to transition public assistance recipients to the workforce.

<u>HB 1788</u> <u>Status</u>	RELATING TO THE ROOM CONFINEMENT OF CHILDREN AT DETENTION AND SHELTER FACILITIES. Limits the circumstances under which children and minors at shelters may be subject to room confinement, and specifies the conditions and time limits for which room confinement may be imposed.	HSH, JUD, FIN
HB 1870 Status	RELATING TO LONG-TERM CARE INSURANCE. Requires the thirty-day lapse or termination notices for long-term care policies to be sent by certified mail or commercial delivery service, or other method of delivery requiring proof of delivery.	HSH, CPC, FIN
<u>HB 1942</u> <u>Status</u>	RELATING TO CHILD ABUSE REPORTING. Adds members of the clergy, commercial computer technicians, and commercial film and photographic print or image processors to the categories of persons who are required to report child abuse and neglect to the Department of Human Services or to police. Provides a "safe harbor" through December 31, 2020, for reporting by clergy of known or suspected child abuse that was previously unreported and that did not arise during a penitential communication.	HSH, JUD, FIN
HB 2050 Status	RELATING TO TEMPORARY RESTRAINING ORDERS, PROTECTIVE ORDERS, AND INJUNCTIONS. Clarifies that the effective period of a protective order, temporary restraining order, or injunction restraining any party from contacting, threatening, or physically abusing a minor may extend to a date after the minor has reached 18 years of age.	HSH, JUD, FIN
HB 2061 Status	RELATING TO CHILD SUPPORT. Requires certain amounts of child support moneys collected by the Department of Human Services (DHS) for public assistance of a child to pass through to the family receiving public assistance. Requires DHS to disregard passed through child support payments when calculating the income of an applicant for or recipient of public assistance. Increases the maximum fine for an employer who discharges from employment, refuses to employ, or takes disciplinary action against any noncustodial parent subject to income withholding or who fails to comply with an order of assignment of future income to pay child support. Appropriates funds.	HSH, JUD, FIN
HB 2062 <u>Status</u>	RELATING TO THE SEXUAL EXPLOITATION OF CHILDREN. Establishes within the Department of Human Services a sexually exploited children statewide coordinator and program and a commercial sexual exploitation of children steering committee to address the needs of sexually exploited children in the State. Requires the sexually exploited children statewide program and the commercial sexual exploitation of children steering committee to provide annual reports to the Legislature. Establishes within each county a commercial sexual exploitation of children multidisciplinary team to facilitate the sharing of information and to immediately respond to cases of sexually exploited children. Appropriates funds.	HSH, JUD, FIN
