(HSCR213-20) Status Establishes the retirement savings task force to secure a consultant to assess the feasibility of a Hawaii retirement savings program; research the implications of the enactment of the federal SECURE Act; draft an implementation plan for the retirement savings program; and submit a report to the legislature. Appropriates funds. Sunsets the task force on 6/30/2021. Takes effect on

1/1/2050. (HD1)
