HB 583, HD1 (HSCR131-20) **Status**

RELATING TO CANNABIS FOR MEDICAL USE.

Allows primary caregivers, qualifying out-of-state patients, and caregivers of a qualifying out-of-state patient to access the restricted access area within a medical cannabis retail dispensary. Clarifies violations related to medical cannabis dispensaries and makes other conforming amendments to the State's medical cannabis dispensary

law. Effective 7/1/2050. (HD1)

HB 2043, HD1 (HSCR57-20) Status

RELATING TO ADOLESCENT MENTAL HEALTH CARE.

Allows an unlicensed mental health professional, working under the supervision of a licensed mental health professional, to provide mental health treatment or counseling services to minors without parental or legal guardian consent, knowledge, or participation. Requires a mental health professional to assist a minor with completing a nondisclosure notification form to send to covered entities, when appropriate. Requires a covered entity, upon receiving a completed notification form, to maintain the confidentiality of minor-initiated mental health treatment or counseling services. Takes effect on 7/1/2050. (HD1)

HB 2590, HD1 (HSCR191-20) **Status**

RELATING TO AUTONOMOUS VEHICLES.

TRN, JUD/CPC, FIN

Establishes within DOT a two-year autonomous vehicles testing pilot program. Requires report to the legislature. Appropriates funds. Effective 7/1/2050. (HD1)

DECISION MAKING TO FOLLOW
