RELATING TO FIREARMS.

PVM/JUD

(SSCR3282) Status Prohibits the manufacture, possession, sale, barter, trade, gift, transfer, or acquisition of detachable ammunition magazines with a capacity in excess of ten rounds, regardless of the type of firearm with which the magazine is compatible, except for magazines that was legally possessed prior to this Act. Prohibits the sale, barter, trade, gift, transfer, or acquisition, except by means of inheritance, of such large-capacity magazines. Makes an exception for possession and use by law enforcement agencies and officers. (SD2)

RELATING TO CORRECTIONAL FACILITIES.

PVM/JUD, FIN

(SSCR3250) Status Establishes procedures for the use of administrative and disciplinary

segregation in correctional facilities. (SD1)

SB 3054, SD2

RELATING TO FIREARM REGISTRATION.

PVM/JUD

(SSCR3255) Status Requires the registration of firearms that are moved out of the State.

Imposes a fine of \$250 per firearm for violations. (SD2)
