Status & Authorizes the withholding and revocation of vehicle registrations and driver's licenses for those who abandon a vehicle under specified conditions. Authorizes the assessment and collection of charges relating to change and detailed.

Testimony and collection of charges relating to abandoned and derelict vehicles. Takes effect on 7/1/2050. (HD1)

HB 2590, HD2 RELATING TO AUTONOMOUS VEHICLES. TRS. CPH/WAM

(HSCR855-20) Establishes within DOT a two-year autonomous vehicles testing pilot program. Requires report to the legislature. Appropriates

Status & funds. Effective 7/1/2050. Sunsets 6/30/2022. (HD2) Testimony

HB 2674, HD1 RELATING TO MOTOR VEHICLE REGISTRATION. TRS, JDC

Provides that any authorization by a county director of finance for an electronic method of motor vehicle registration, including the acceptance of any supplemental documents in electronic form, shall extend to all types of motor vehicles. Takes effect on
