RELATING TO INCREASING THE OFFICE OF HAWAIIAN AFFAIRS' PRO RATA SHARE OF PUBLIC LAND TRUST

FUNDS.

Status &

Establishes \$ as the Office of Hawaiian Affairs' pro rata share of the public land trust. Transfers \$ less certain funds to the Office of Hawaiian Affairs for underpayment of the public land trust funds for 7/1/2012 to 6/30/2019. Requires the Director of Finance to make up the difference between a specified minimum amount and an amount of public land trust receipts from an agency to the Office of Hawaiian Affairs by transferring the difference into the carry-forward trust holding account. Requires the Department of Land and Natural Resources to provide an annual accounting of receipts from lands described in section 5(f) of the Admission Act.

Establishes a committee to recommend the annual amount of the income and proceeds from the public land trust that the Office of Hawaiian Affairs shall receive annually. Appropriates

RELATING TO THE HAWAII TECHNOLOGY DEVELOPMENT

CORPORATION.

Prohibits a company from receiving a grant in consecutive years under the manufacturing development program.

RELATING TO IMPORTANT HOUSING LANDS.

Establishes that important housing lands are public lands owned by the State that are located within 1.0 miles of any rail mass transit station and needed to promote the development of homes priced below market rates for Hawaii residents who are owner-occupants and own no other real property, in perpetuity.

Requires the State and counties to identify and designate important housing lands. Appropriates funds. (SD1)

RELATING TO HOUSING.

Requires state or county agencies to issue discretionary permits for housing development projects that meet certain requirements within sixty days of receipt of a permit application deemed to be complete by the receiving state or county agency. (SD1)

RELATING TO TAXATION.

Establishes an empty homes conveyance tax against certain residential property owners who own a vacant residential unit in

the State. (SD1)

RELATING TO THE USE OF INTOXICANTS WHILE OPERATING A VEHICLE.

Deposits fines for repeat offenders, habitual offenders, and offenders who operate a vehicle after license and privilege have been suspended or revoked for operating a vehicle under the influence of an intoxicant into a state drug and alcohol toxicology testing laboratory special fund to be administered by the

Department of Health. (SD1)

RELATING TO AGRICULTURE.

Establishes the agricultural enforcement program and agricultural enforcement special fund within the Department of Agriculture. Authorizes the Board of Agriculture and agricultural enforcement officers to exercise police powers. Extends to the agricultural enforcement program the applicability of certain statutory provisions relating to the law enforcement officer independent review board; possession of electric guns; the law enforcement standards board; emergency vehicles; and worker's compensation for volunteer emergency response personnel. Authorizes the use of funds in the agricultural development and food security special fund for protection of agricultural resources. Appropriates funds. (SD1)

RELATING TO LESS THAN LETHAL FORCE.

Requires the department of public safety to review its policies and procedures governing the use of force, weapons, and equipment. Requires the law enforcement standards board to review the department's use of force training. Appropriates funds for training, equipment, and related records management

for the department.

RELATING TO THE ENVIRONMENT.

Requires state agencies to participate in a carbon offset program to offset carbon emissions caused by their employees' air travel. Requires the Department of Land and Natural Resources and Department of Budget and Finance to establish

and administer a carbon offset program. (SD1)

Requires the Board of Agriculture to annually report an accounting of non-agricultural park lessees to the Legislature. Makes an appropriation. (SD1)

misdemeanor penalty for failing to register and replacing it with a civil fine structure and to make various technical amendments.

Establishes a Statewide Interoperable Communications Executive Committee for public safety communications and the position of the Statewide Interoperable Communications Coordinator. (SD1)

Establishes authorized cultivation of hemp as affirmative defense. Excludes hemp from the definition of marijuana. Requires chairperson of board of agriculture to prepare a state plan for approval of the federal Secretary of Agriculture and report on the approval process to legislature and governor. Appropriates funds. Takes effect 7/1/2050. (SD1)

RELATING TO VOTING.

Requires that any person who is eligible to vote and applies for a new or renewal motor vehicle driver's license, provisional license, or instruction permit, or a new, renewal, or duplicate identification card be automatically registered to vote if that person is not already registered to vote unless the applicant affirmatively declines to be registered to vote. Authorizes access to and electronic transmission of databases maintained or operated by the counties or the department of transportation containing driver's license or identification card information to election officials and the statewide voter registration system. Effective 1/1/2021.

Requires that e-liquid and electronic smoking devices be included within the definition of "tobacco products", as used in the cigarette tax and tobacco tax law. Increases the license fee for persons engaged as a wholesaler or dealer of cigarettes and tobacco products. Increases the retail tobacco permit fee for retailers engaged in the retail sale of cigarettes and tobacco products. Allocates a portion of funds collected on excise taxes on tobacco products to fund health education, prevention, and nicotine cessation programs for youth, regarding the risks and dangers of the use of electronic smoking devices. Repeals certain provisions of the Hawaii Revised Statutes relating to electronic smoking devices. Effective 9/1/2020. (SD1)

RELATING TO EDUCATION.

Amends the minimum qualifications for nominees to the State Public Charter School Commission to require residency in the State. Provides that commission members may be reimbursed for necessary and reasonable travel expenses incurred in the conduct of official commission business.

Requires Department of Education school football programs to ensure that each non-new football and privately purchased football helmet and other safety equipment used in a football program is reconditioned and recertified at least once every two years. (SD1) TRS, JDC/WAM

RELATING TO CHILD SUPPORT.

Requires certain amounts of child support moneys collected by the Department of Human Services (DHS) for public assistance of a child to pass through to the family receiving public assistance. Requires DHS to disregard passed through child support payments when calculating the income of an applicant for or recipient of public assistance. Increases the maximum fine for an employer who discharges from employment, refuses to employ, or takes disciplinary action against any noncustodial parent subject to income withholding or who fails to comply with an order of assignment of future income to pay child support. Appropriates funds. Effective 7/1/2021. (SD1)

RELATING TO THE HAWAIIAN HOMES COMMISSION. Allows the Hawaiian homes commission or the department of Hawaiian home lands to retain independent legal counsel as needed. Authorizes the Hawaiian homes commission and the department of Hawaiian home lands to use the services of the

attorney general as needed and when the interests of the State, Hawaiian homes commission, and department of Hawaiian home lands are aligned. Provides that funds paid to independent legal counsel shall be paid by the State.

RELATING TO TRAFFIC VIOLATIONS.

Repeals several exemptions from the prohibition on operating a pickup truck with a passenger seated in the bed or load-carrying area, including the exemption that allows passengers over twelve years of age to ride in the bed or load-carrying area. Reduces the fine for violating the prohibition. (SD1)

Limits the monthly amount of **Testimony** reimbursement. Effective 7/1/2050. (SD1) SB 3055, SD1 RELATING TO MOPEDS. TRS/CPH, Requires a transition to silent, clean electric mopeds by JDC/WAM (SSCR2706) prohibiting a retailer from selling or offering for sale combustion engine-powered mopeds beginning January 1, 2022.
