## **DECISION MAKING ON THE FOLLOWING MEASURE(S):**

SB2101 RELATING TO TAXATION. WAM

Status and Testimony Amends the excise tax rate on large cigars.

SB2602 RELATING TO ESTATE TAX INFLATION ADJUSTMENT. WAM

Status and Testimony Requires Hawaii's estate tax applicable exclusion amount to be

calculated by utilizing the federal Internal Revenue Service

inflation adjustment mechanism. Applies only to decedents dying

after December 31, 2019.

SB2624 RELATING TO THE LOW-INCOME HOUSEHOLD RENTERS WAM

Status and Testimony CREDIT.

Creates income brackets for the low-income renter tax credit. Provides for adjustment of the tax credit amount based on the

consumer price index.

SB3124 RELATING TO TAXATION. WAM

Status and Testimony Amends the income tax rates by changing the tax brackets

beginning after 12/31/2020.

SB2052 SD1 RELATING TO LOAN FORGIVENESS FOR EARLY CHILDHOOD EDU, WAM

(SSCR2352) EDUCATION PROFESSIONALS.

Status and Testimony Adds early childhood education students to the Hawaii educator

loan program to allow the education loans of those individuals to be forgiven after five years teaching in early childhood education.

Appropriates funds. (SD1)

RELATING TO TEACHER RECRUITMENT. SB2256 SD1 EDU, WAM (SSCR2316) Authorizes the department of education to provide incentives to Status and Testimony enhance the recruitment and retention of public school and public charter school teachers. (SD1) RELATING TO SERVICE IN NON-CRIMINAL PROCEEDINGS. JDC, WAM HB766 HD1 SD1 (SSCR1284) Establishes a task force within the Judiciary to review allowing Status and Testimony service of notice and process by electronic mail in civil and administrative proceedings. (SD1)
