RELATING TO TAXATION.

Changes the amount of the rental motor vehicle surcharge tax from \$5 to an unspecified amount. Effective 7/1/2050. (HD1)

Changes income tax rates for taxable years beginning after 12/31/2020. (HD1)

RELATING TO THE MANAGEMENT OF STATE FUNDS.

Amends provisions relating to the short-term investment of state moneys, including the types of financial instruments in which state moneys may be invested. Requires annual report to the legislature. Effective 1/1/2050. (HD1)

RELATING TO TAXATION.

Provides that Chapter 1, Subchapter Z (with respect to opportunity zones), of the Internal Revenue Code shall not be operative for the purposes of state income tax law. Takes effect on 7/1/2112. Applies to tax years beginning after 12/31/2022. (HD1)
