#### **Registered Nurse VI**

Manage and Supervise a team consisting of two (2) office assistants, four (4) professional nurses (3 RN IVs, 1 RN V) and two (2) Social Workers who provide oversight and contract monitoring assuring the quality of care and services provided by AlohaCare, HMSA, Kaiser, Ohana and United HealthCare through the managed care system.

Manage and provide direct oversight, supervision and guidance to three (3) RN IVs and three (3) RN Vs in the areas of Long Term Services and Supports, Home and Community Based Services, Early Periodic Screening Diagnosis, and Treatment (EPSDT), Developmental Disability/Intellectual Disability (DD/ID) Waiver Services, Community Care Services (CCS), and External Quality Review Organization. Participates in joint meetings and planning sessions with other administrators and personnel from other divisions, community groups and providers, to determine best practices and methods of providing quality services to beneficiaries within the boundaries of federal and state guidelines.

Manage and provide direct supervision over the work of two (2) social work positions in all phases of the Appeal and Grievance process and approves the findings/results for review, confirmation and/or preparation for hearing.

Advise and support the RN V with the State Transition Plan to ensure that the State is in compliance with the Final Rule for Home and Community Based Services from the Centers for Medicare and Medicaid Services (CMS). Collaborate with representatives from the MedQUEST Division (MQD), Department of Health (DOH), Council Members, and Advisory Groups in the development of policies and procedures and plans to evaluate and assist service providers to come into compliance with the Final Rule. Regularly participate in SOTA webinar calls to ensure that changes to the federal rules are reflected in the designing of programs and the creation or revision of policies and procedures governing these programs. From September 2013 through March 2014, directed the transition of approximately 4500 QExA and QUEST members from the Adult Mental Health Division (AMHD) and QUEST health plans into the Community Care Services (CCS) program that serves beneficiaries with severe and persistent mental illness. The transition increased the total of CCS members to over 5000 and has remained in that range since. Collaborated with the Data Analysis and Provider Network (DAPN) Section and Systems Office to assure accurate data from the transition were provided and inputted into our system. Developed and implemented procedures for CCS admission criteria, reviewed all referrals and approved admissions that met the requirements of the program. Developed a workflow checklist and revised the referral application to streamline the referral process and assure the information required was included in the application. Monitor and provide direction to CCS through monthly reports to improve the type and frequency of services provided that assure member needs were being met. Conducted informational training on the CCS referral process/criteria for hospitals, community providers/agencies, and other state departments. Implement and manage pilot programs to expedite CCS admissions for persons that meet criteria entering the system through the Crisis Line, Hawaii State Hospital, and adults transitioning from Child and Adolescent Mental Health Division. Currently working with DD Division in developing a procedure for admission into CCS for their members that have dual diagnosis and may qualify for the CCS program.

Developed and implemented and continue to provide oversight of the Ride Along Program that evaluates the process and accuracy of Health and Functional Assessments performed by health plans service coordinators to determine the needs of beneficiaries requiring LTSS, HCBS, or At Risk services. Evaluation findings are provided to the health plans on a quarterly basis. Consultation provided to the health plans on an "as needed" basis.

Provides monitoring and direction over the Quality Assessment Performance Improvement (QAPI) Program through Performance Improvement Projects (PIPS). PIPS are designed to achieve through ongoing measurements and interventions, significant improvement, sustained over time, in clinical care and non-clinical areas that are expected to have a favorable effect on health outcomes and member satisfactions.

Designates staff in the seven (7) specialized areas within the Quality Section to address work requirements and policies and procedures in the identification, evaluation and resolution of potential and actual problems in meeting the requirements of the contracts and the delivery of services to beneficiaries. Works in conjunction with the other two Section Supervisors within the branch in recommending implementation of health care evaluation processes and protocols for quality assurance in monitoring the contracts.

Provide oversight and recommend approval for budget disbursements for the "Hawaii Patient Reward and Incentive Program to Support Empowerment - HI-Praise Project" through a University of Hawaii grant under the coordination of a Quality Section staff.

## Registered Nurse V Unit Supervisor Office of Health Care Assurance

The RN V functions as the Unit Supervisor of a team of four (4) Registered Nurse IV's, a Public Health Nutritionist and an Occupational Therapist IV. The RN V is responsible to plan, organize and coordinate a variety of support services to implement Administrative Rules governing providers of medical facilities. Develop standards, policies and procedures as required to ensure quality of care for residents placed within these facilities. Evaluate statistical data to monitor programs for quality assurance and effectiveness and to recommend program changes based on these evaluations and established standard nursing practice and procedures. Evaluate and process new applicants for Care Homes, Developmental Disability Domiciliary Homes, Special Treatment Facilities, Therapeutic Living Facilities, and Assisted Living Facilities, through the licensing process until completion of construction, evaluating program objectives, of staff and ensuring that activity and ancillary programs are implemented by the providers. Consult and collaborate with other regulatory agencies at the county and state level. Conduct and complete investigations of unlicensed activities, and violations of resident rights. Works collaboratively with other State and County agencies in these situations as needed.

The program is designed to treat clients in a highly structured environment that provides extensive individual therapy, group therapy, education and training, medication management and close follow-up with program's psychiatrist and professional staff. The intensive treatment is provided in an effort to prevent rehospitalization.

The RN provides **comprehensive** admission **nursing assessments**, assists the psychiatrist in all admission orders, coordinate treatment with collaborative agencies, monitors and administers medication, monitor on-going **health status** of residents, **crisis intervention**, and provide 1:1 counseling as needed. Conducts **authorization interviews** with insurance providers for continued treatment. Involved in all aspects of planning, implementing and evaluating program activities. Assumes the duties and responsibilities of the **Program Administrator** during her absence. Preceptor of **nursing students** from local universities.

Serves as the **Utilization Review nurse**, is familiar with Medicare/HMO rules and regulations, conducts education and training groups daily, participates in interdisciplinary treatment planning and reviews, conducts home visits as necessary, **assess client's physical status and refer or follow-up** with appropriate agencies.
