## SKILLS, ABILITIES, AND ATTRIBUTES

### **Management:**

In the current position of Director of Risk Management, I am directly involved in and oversee all safety program development and implementation spanning six retail, three manufacturing, and two support branches and located on three islands in the state. As previously noted, my past professional experience in government and emergency management have supported and enhanced my role as the Director of Risk Management and enabled the organization to support and assist with various community endeavors that included the response and recovery to recent disaster events. With those events and incidents I was tasked with serving as the organization's liaison to local and state government and other response and recovery agencies.

I retired as the Administrator of the Hawai'i County Civil Defense Agency in May of 2016 after three years in that role. In that position and capacity, I was responsible for the direct management and oversight of the county government level emergency management office and tasked with the coordination of all local or island wide disaster response and recovery operations and activities. This included but was not limited to the development of emergency response plans, directing the operations of the Emergency Operations Center or EOC, coordinating the various multi-agency response activities, facilitating processes for requesting assistance and the initiation of state and federal disaster assistance programs, developing public education and notification programs and systems, and serving as the Public Information Officer for the County of Hawai'i as it relates to emergency and disaster events or incidents. Recent notable accomplishments include the direct management and coordination of emergency response and recovery operations for Hurricane/Tropical Storm Iselle, the June 27, 2015 volcanic eruption and lava flow threat event, and the coordinated response to the Dengue Virus outbreak on Hawaii Island. In considering my application for employment in this position and capacity, selection and consideration was given to my knowledge and experience in emergency management as well as my personal commitment to public service and community safety and welfare. In addition to the direction and coordination of emergency operations, as the Administrator I was responsible for the day to day management of the agency and all normal business activities inclusive of but not limited to: development of the organizations operating and capital improvement budgets, management of all department personnel, development of organization policies, procedures, and the development and delivery of public information and education materials and programs.

With regards to my prior experience in emergency and public safety management as the former Fire Chief of the Hawai'i Fire Department, I had the opportunity to direct and command a variety of large and complex emergency incidents as well as participate in the development of emergency response plans and operational policies, procedures, and guidelines. I retired with over thirty-one (31) years of firefighting, paramedic, search and rescue, aero-medical, hazardous material response, and administrative experience with the Hawai'i Fire Department.

As the first Fire Commission appointed Fire Chief of the Hawaii Fire Department, I was committed to ensuring that the organization would not only meet its service obligations and performance measures at that time but would also be prepared to meet the future needs and demands of the community. To achieve this goal, I assembled a team of representatives from every operational unit of the organization to collaboratively develop the department's first "Strategic Plan". This document articulated the vision, mission, core values, and strategic focuses of the department as well as identified key performance measures that would be strived for over the subsequent five to ten years.

Through this inclusive, collaborative, and very transparent process, members of the organization not only understood the direction and plans, but more importantly, bought into and supported the goals and objectives that were set forth.

As part of my management of the department, I directed a workforce comprised of 505 paid personnel (421 fire fighters, 46 water safety officers, and 38 support staff), and 243 volunteer fire fighters. Further, the organization consisted of (20) 24-hour fire companies, 15 advanced life support ground ambulance units, one advanced life support aero-medical unit, two rescue companies, two hazardous material units, and 25 volunteer companies. These resources were committed to serve and protect a resident population of over 180,000 along with the thousands of daily visitors and serve an area of over 4,000 square miles. The annual mission call volume is over 21,000 calls per year, with approximately 80% pertaining to emergency medical services incidents. The fire department's annual budget at the time of my retirement was approximately \$35 million.

**Communication:**

Throughout my careers in both the fire service and most recently in the arena of emergency of emergency management with the Hawai'i County Civil Defense Agency, I have had countless opportunities to develop and employ communication style and ability that projects confidence and professionalism while promoting and fostering trust in government. This has been attributed to my commitment to actively listen to our community members and to communicate with respect, honesty, and empathy. In the face of crisis and uncertainty, it was critical to not only provide timely, accurate, and thorough information but to also manage the expectations of affected or potentially affected residents and businesses. I also found it to be invaluable to identifying gaps and making improvement to various elements of our operations by soliciting candid and frank feedback from affected community members and not only consider their suggestions and recommendations but to also integrate key community organizations such as community associations into the formal processes of preparedness, response, recovery, and mitigation.
