Aloha Chair Dela Cruz and Committee Members:

Thank you for considering my nomination as Director of Finance.

I was appointed to this position over a half year ago. At the time, the severity of the impending social, economic, and financial impacts of the COVID-19 pandemic were not yet understood but addressing the virus and its consequences is now the top priority of the Department of Budget and Finance.

The State is fortunate to have many experienced, knowledgeable, and industrious leaders, public servants, and residents that took the State out of the last recession to what was until recently a relatively strong financial position. The work the Legislature, the Administration, and Hawaii's residents and taxpayers did to shore up reserves and address liabilities may allow us to stave off the worst state budgetary consequences we would otherwise need to endure. There is a lot of work ahead and many difficult choices will need to be made. My education and background will allow me to do my part and engage in our collective efforts to determine where Hawaii needs to go and how we will get there.

During my recent six year tenure as Executive Director of the Hawai'i Housing Finance and Development Corporation (HHFDC), a State agency with over sixty employees and total assets of \$1,338,689,302 and a total net position of \$1,229,239,061 as of June 30, 2019, I was responsible for the Hula Mae Multi-family Tax-exempt Bond program, the rental housing revolving fund (formerly known as the rental housing trust fund) program, and the dwelling unit revolving fund program. By their nature, these financing programs required significant interaction with the Department of Budget and Finance. I also oversaw the federal and State low-income housing tax credit program and the State general excise tax exemption for certified or approved housing projects.

As the first chair of the State Rental Housing Trust Fund Commission, I was involved with bringing the rental housing trust fund (now known as the rental housing revolving fund) program from legislation, through rulemaking, to implementation. During my tenure as Executive Director, working collaboratively with the Legislature and the Administration, HHFDC made rental housing revolving fund awards totaling close to \$500,000,000 to help finance approximately 4,000 badly needed low-income rental housing units in the State of Hawaii. About 1,500 rental housing revolving fund financed units were also completed during this period. As of June 30, 2019, the rental housing revolving fund was the single largest fund at HHFDC with a total net position of \$782,849,148.

I also served as the chair of the 2001-2003 State Tax Review Commission.

I have a Master of Science in Accounting and a Master of Business Administration from the Wharton School of the University of Pennsylvania and a Master of Laws (in Taxation) from the New York University School of Law. I am a certified public accountant with a permit to practice in the State of Hawai'i and an inactive member of the Hawai'i State Bar Association. Before becoming the executive director of HHFDC in 2013, I practiced as a tax accountant or tax attorney in Hawaii for forty years.

My strengths in the workplace include an accounting and legal background, organizational and administrative skills, experience leading and facilitating the work of State agencies, a working knowledge of public finance in the State of Hawai'i, an understanding of Hawai'i taxes, and the demonstrated ability to manage and reorganize a sixty employee State agency over a period of six years.

Having been the Director of the Department for over six months, I believe that the Department has been fortunate to have experienced staff who have served the State through many administrations. They supported the achievement of the highest bond ratings in the history of the State as a result of responsible budgetary practices and debt management. Their combined institutional knowledge is invaluable and is routinely shared within the Executive Branch and with the Legislative Branch upon request. The Department needs to ensure the retention of this knowledge to see the State through the current COVID-19 pandemic.

As of the beginning of this legislative session, the stated vision of the Department was as follows:

 To be recognized and respected as a leader in prudently developing the State's budget and protecting the State's finances to ensure the sustainability of important public services, including healthcare and pension benefits to State government employees; and The Honorable Donovan Dela Cruz, Chair Senate Committee on Ways and Means July 1, 2020 Page 3

 To be the best organization in the development and administration of public financial resources.

At that time, the goals of the Department were as follows:

- Working collaboratively with stakeholders to produce a thoughtful, well developed, and balanced budget that meets Hawaii's needs while maintaining sufficient reserves;
- Optimize returns on available funds;
- Maximize the receipt, while maintaining sufficient controls over the use of federal funds;
- Effectively manage debt;
- Improve the funding status of the Employees' Retirement System of the State of Hawaii and the Hawaii Employer Health Benefits Trust Fund towards eliminating each program's unfunded liabilities;
- Provide effective legal services while managing caseloads effectively;
- Provide excellent customer service to all stakeholders; and
- Provide a nurturing and rewarding work environment for the Department's team.

Should I be confirmed as Director, I plan to honor the above vision and goals subject to the pressing constraints imposed by the projected \$2,300,000,000 revenue shortfall facing the State for the current biennium. The Department is currently working on:

- Implementing general fund cost saving measures throughout State government;
- Updating of the State's financial plan;
- Preparing for the State's next general obligation bond issue;
- Preparing the budget for the next biennium (which without federal aid could be more challenging than the current biennium);
- Evaluating how best to utilize the Federal Reserve's Municipal Liquidity Facility as authorized by the Legislature this session; and

 Modernizing the State Financial System with DAGS and ETS in order to more efficiently track State expenditures and budget variances.

The Department looks forward to working collaboratively with the Legislature to redesign State government in order to effectively deal with a COVID-19 world.
