I currently serve as Executive Director of the U.S. Climate Alliance, a bipartisan coalition of 25 governors working together to achieve the goals of the Paris Agreement. Governor Ige was one of the first governors to join the Alliance, with Mr. Glenn serving as his representative to the Alliance. Prior to joining the Alliance, I served as a Senior Advisor to the Special Envoy for Climate Change at the U.S. Department of State, where I had the great honor of helping to advance the most progressive climate agenda in U.S. history, a vision set forth by President Obama.

Under Governor Ige's leadership, Hawai'i continues to take aggressive action to combat climate change, inspiring other states to do the same.
