Subject: Letter of Recommendation For Mr. Kevin Nakamura to fill the Department of Health/Wastewater Branch seat of the Board of Certification for Wastewater Operators in Wastewater Treatment

In my professional capacity as a licensed engineer and the Chief of the Division of Wastewater Engineering and Construction (WEC), Department of Environmental Services (ENV), City and County of Honolulu (C&C), I endorse Mr. Kevin Nakamura for a seat on the Board of Certification for Wastewater Operators in Wastewater Treatment.

ENV has a huge commitment to upgrade Honolulu's wastewater infrastructure via the Global Consent Decree (GCD) with the Environmental Protection Agency (EPA) and administered by Federal Court. ENV's commitment to improvement of the wastewater system is witnessed by an average of \$534 Million of capital improvement projects over the last 5 years. 2020 effectively begins the wastewater treatment plant secondary treatment upgrade phase of the GCD, estimated at a cost of up to \$3 Billion. While the upgrades to the treatment plant facilities may be state-of-the art; without the proper operators to operate and maintain the treatment facilities, the plants will not achieve the treatment necessary to meet regulatory and health and safety requirements.

I have known and worked with Mr. Nakamura for over 25 years. He headed the operations at the Sand Island Wastewater Treatment Plant (WWTP), the largest wastewater treatment facility in the State. Mr. Nakamura had the skills necessary to meet stringent effluent limits, understood treatment process controls, and could and did adjust to changes in influent sewage in order to meet treatment standards. As a supervisor and Grade IV Licensed Operator, Mr. Nakamura trained and oversaw a large operations staff, and knows what it takes to be qualified to run treatment processes. He is a no-nonsense, committed individual with the utmost integrity. I believe that this experience would make him an excellent member of the Board of

Certification. He would be a very knowledgeable and fair judge of whether a candidate would deserve certification and licensing.

Those who know me have commented that I have very high standards. In my twenty-six years as a licensed professional engineer, I have consented to write only two letters of recommendation while having been requested by over a dozen individuals. One was for the Director of a City department, and the other is for Kevin. Kevin's dedication, integrity and experience cannot be captured by words only; so this letter of recommendation does not do him justice.
