She has provided technical support to many of the operators who call with questions on the certification process, and she interacts well with them.

Thank you for the opportunity to present myself. Here are responses to your questions. Please let me know if I should submit this via other means.

(1) Why do you wish to be a member of the Board of Certification of Public Water System Operators?

My position in the Department of Health Safe Drinking Water Branch is responsible for the implementation and administration of a drinking water operator certification program, and my duties include making recommendations to the Board. Per HRS Chapter 340F, Mandatory Certification of Public Water System Operators, one individual on the Board should be from the Safe Drinking Water Branch, and my service would fulfill this requirement.

(2) What do you perceive are the roles and responsibilities of a member of the Board of Certification of Public Water System Operators?

The duties of the Board are to carry out the provisions of HRS Chapter 340F, Mandatory Certification of Public Water System Operators, which contributes to the Safe Drinking Water Branch's mission to safeguard public health by assuring that operators of public water systems provide safe drinking water to the community. Each Board member has the responsibility to ensure the integrity of the operator certification program.

(3) Given your understanding of the roles and responsibilities of a Board of Certification of Public Water System Operators member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board.

I have been in my current position which is responsible for the implementation and administration of a drinking water operator certification program for nearly 13 years. Since I also provide technical assistance in response to drinking water operators' requests, I understand the challenges from both an operators' perspective as well as the regulatory position. Therefore, I can give fair-minded input to critical Board decisions.

- (4) What do you hope to accomplish during your term of service?

  I hope to ensure the integrity of the drinking water operator certification program.
- (5) Name three qualities that best describe you and how these qualities will benefit the Board of Certification of Public Water System Operators.
  - 1) I listen first in any situation and that should help me to make decisions with knowledge from all positions.
  - 2) I thoroughly research all issues before coming to conclusions which should provide fair assessments.
  - 3) My perspective of the water industry from a regulatory viewpoint is not compromised because I have no affiliation with any water purveyor.
- (6) Name a previous experience you've had that will be beneficial as a Board of Certification of Public Water System Operators member.

Prior to working in the Safe Drinking Water Branch, I worked for a defense corporation that designed and manufactured cockpit displays for military aircraft. I coordinated all

supplier certification activities to produce a core group of suppliers that could be depended upon to manufacture quality product for military fighter aircraft that provided a means of defense for our nation. The fundamental basis for the development of that supplier certification program is very similar to the drinking water operator certification program that the Board resides over. I will be able to apply my knowledge and experience toward using good judgement in making decisions to maintain the standards set for the certification of public water system operators.

(7) Can you foresee any possible conflicts of interest that could arise during your service on the Board of Certification of Public Water System Operators? How would you overcome conflicts of interest?

I do not foresee any possible conflicts of interest, however if any should arise, I understand the procedures of the Board as they are dictated in HAR Chapter 11-25, Rules Relating to Certification of Public Water System Operators, as concurrence of a majority of all members shall be necessary to make any action of the Board valid.
