This testimony is in **strong support** of the nomination of Edith Ignacio Neumiller to the Hawaii State Commission on the Status of Women. Ms. Ignacio Neumiller is currently a member and serves as Secretary of Kauai County's Committee on the Status of Women. She is an active member and is readily acknowledged as a leader. In recognition of her contributions, she was selected by the members to attend the National Association of Commissions for Women (NACW) conference on four (4) separate occasions, in 2016, 2017, 2018 and 2019.

One of the things I admire about Edith or "Edie" as we like to call her, is her focus and determination. Many individuals go to conferences and there is little in the way of initiatives or improvements to show for the investment. Edie went to the NACW conference and listened to a presentation on Human Trafficking of girls and women.

In 2019, due to her efforts, Kauai's Committee on the Status of Women (CSW) conducted a public forum on Human Trafficking on Kauai. At the forum, Dominique Roe-Sepowitz, MSW, Ph.D., from Arizona State University presented her groundbreaking research and data on Human Trafficking with Hawaii specific metrics.

In January 2020, as a direct result of the 2019 forum, Dominique Roe-Sepowitz returned to do another presentation with Kauai specific research and data in addition to a panel discussion with Chief Todd Raybuck (Kauai Police Department), Justin Kollar (Prosecuting Attorney), Stefani Iwami (Clinical Director of Sexual Assault Services, YWCA of Kauai) and Jessica Munoz (founder and President of Hoʻōla Nā Pua). The Human Trafficking Forum Part II, was standing room only and generated the momentum to move toward next steps which was planned to be rolled out this summer.

While the current pandemic has certainly curtailed activities, I have no doubt that the initial plans to post information on getting help in schools, bars and airports will move forward as soon as possible.

Ms. Ignacio Neumiller is also active in the community with many events and organizations like the Kauai Filipino Chamber of Commerce and she has been member of Zonta for the past 16 years. Particularly with the Zonta Club, Edie has championed many women's issues.

Kauai needs a representative on the Hawaii State Commission on the Status of Women and Ms. Ignacio Neumiller is an outstanding choice. Thank you for your consideration.

My role and jurisdiction of the Commission is to represent Kauai's Committee on the Status of Women (KCSOW) during the meetings and to provide updated information on the programs and mission of the Commission. To engage the KCSOW and/or partner with similar yearly projects such as Human Trafficking awareness in Hawaii.

To be ethical and honest on my passion in bringing awareness on women and girls issues (i.e., domestic violence against women, human trafficking facts, mentoring young women in high schools, legislative bills relating to women and girls etc.)

As a member since 2004 with the Zonta Club of Kauai I served as Past President, Secretary, Programs & Advocacy Committee, Public Relations Committee & Fellowship Committee. Currently, I am the Area 1 Director for four (4) Hawaii Clubs from July 2018 to July 2020. I am advocate for issues relating to the Zonta Says No to Violence Campaign, 16 Days of Activism, Denim Day, Equal Pay Day, and other Zonta International programs.

#### Skills

My strengths relay on supporting and coordinating a seven (7) member board, setting up board monthly meetings that includes administrative tasks, occasional research and knowledgeable of the Sunshine Law.

5. What do you hope to accomplish during your term as a member of the Commission?

To be an active State Commissioner representing Kauai by engaging in all of the State programs and legislative issues. Currently, I attend all CSOW monthly meetings because I in invested in the programs we have done.

6. What issues do you believe that the Commission has handled well in the past? What issues do you believe that the Commission should address in the future?

I have attended four (4) of the annual conferences of the National Association of Commission for Women (NACW) when they were hosted in Honolulu 2016, Boston 2017, Los Angeles 2018 and Chicago 2019. Most memorable was the Los Angeles NACW where a video was shown of a 12 year old girl that was trafficked in Los Angeles. During the presentation, I knew I wanted to bring the Human Trafficking issue back to Kauai as a forum to highlight studies, statistics, and trafficking facts in Hawaii especially on Kauai. On January 9, 2020, we had a standing room only with 85 people in attendance to the Human Trafficking Forum that included six (6) hand-picked panelist and two professional presenters. KCSOW plans to work on Human Trafficking "next steps" FY 2020-2021.

Future issues to be addressed with the Commission could be the continued partnership with other island on the tracking results on Human Trafficking in Hawaii. Possibly education students in the schools.

7. Can you foresee any possible conflicts of interests that could arise during your service on the Commission? How would you overcome any possible conflicts of interest?

Currently, I don't foresee any conflicts on my service with the Commission. If there was a conflict on an issue, I would be honest and to bring it up on a one-on-one with the Executive Director.

8. Is there any other information regarding your experience and background that you believe should be considered for your nomination?

Most information on my experience are in the answers for question no. 4. In addition, I have more than 30 years of administrative experience, 9 years of Human Resources and 5 years of supervisory experience.
