Re: Nomination to the Commission on the Status of Women

Congratulations on being nominated by Governor David Y. Ige to the Commission on the Status of Women. To assist the Committee with its preparation for the confirmation process, I am requesting that you submit to my office a written statement that addresses the following questions. As other Senate committees have done, I intend to make your responses public and post them with testimony on the State legislative website.

1. Please describe your understanding of the role and jurisdiction of the Commission on the Status of Women (Commission).

The commission serves as a voice for women across the state, with representation from each island offering perspectives to the State's Governmental leaders. It brings current issues forward that might otherwise be overlooked and makes sure women's voices are considered at every level of government.

2. How do you perceive the role and responsibilities of a member of the Commission?

I think it's important that members are active in their communities, active with diverse groups of women so they can best represent their unique island/county. It's important to have positive working relationships with other women's organizations and with a wide range of cultures, ages, religions, etc. to ensure strong representation. I think a commissioner should be sure to check in with their constituents prior to meetings and after meetings for good communication and transparency.

3. Why do you wish to serve as a member of the Commission? Please note if you initially applied to be nominated to the Commission or if you were invited to apply.

I have worked in women's empowerment for over 30 years, mostly in Maui County, and mainly in the field of domestic violence. I care very deeply for my community and have vast knowledge, training, expertise, passion and interest in helping the lives of women in my community, locally, statewide, nationwide and globally.

I applied to serve on the Commission as a way to continue helping women and because I thought my perspective and years of experience would be helpful. I think my connections to a wide variety of Maui County groups and individuals brings a unique perspective to this role.

When I ran the domestic violence program here on Maui I worked with so many groups, organizations, service clubs, churches, groups, other non-profits, government, local and state officials, private businesses, etc. I still maintain positive relationships with these groups and individuals which is another asset I bring to the Commission.

4. Please describe why you believe that you are qualified to be a member of the Commission. Please discuss any skills, expertise, knowledge, or volunteer involvement that would aid in your decision-making ability.

Having worked in domestic violence for over 34 years, so much of that work is rooted in gender inequality, gender analysis and how women's lives are different based solely on gender. It also includes considerations of racism, homophobia, class bias, genocide, colonization and historical trauma. Having studied these issues deeply over time and trained and mobilized people with this knowledge I think my perspective at the Commission is valuable.

I am a woman of color, three generations of immigrant ancestors from Japan and Portugal, I am a survivor of domestic violence and more recently, breast cancer, I am a mother, grandmother, sister, aunty. I am a qualified expert in the field of domestic violence. I am president of Soroptimists International/Maui, a service club of women working to empower women and girls through education. And I still have so much to learn.

5. What do you hope to accomplish during your term as a member of the Commission?

I would love to see more work being done to address the impacts of generational trauma and poverty on Native Hawaiian women and children. I'd love to see a living minimum wage, paid family leave that affects women caring for both their children and their parents disproportionately. I'd like to plant the seeds for the creation of housing subsidies for single women with children.

6. What issues do you believe that the Commission has handled well in the past? What issues do you believe that the Commission should address in the future?

I think the Commission has done a terrific job of coordinating legislative efforts from a wide base of constituents via the Women's Coalition. This is a tough task to manage given everyone's perspectives, personal and professional agendas, funding considerations, etc. I feel the Commission has helped create unity and a strong voice for women even if we are

not all in consensus and sometimes with very strong disagreement. As tough as these meetings can be, I think it's very important to have a time, place and mechanism to air our disagreements privately in order to find places where we are united and get behind those issues together.

Issues handled well in the past: domestic violence, stalking, human trafficking, paid family leave, living wage.

Issues moving forward: continued work on domestic violence laws, human trafficking, paid family leave and living wage.

7. Can you foresee any possible conflicts of interests that could arise during your service on the Commission? How would you overcome any possible conflicts of interest?

I work as the Executive Director for a non profit that houses women and children. We do not receive State funding at this time, but that could become a conflict if we applied for a Grant in Aid, but not a direct conflict with the Commission.

Communication is the key and I will keep a vigilant eye out to avoid any conflict and I will communicate with transparency and disclose any potential for conflict quickly.

8. Is there any other information regarding your experience and background that you believe should be considered for your nomination?

I was recently diagnosed with Stage 1 breast cancer and had a mastectomy in January which has healed wonderfully. However, I just completed my first round of chemotherapy and will have another 5 rounds over the course of the next few months. I am out of work on TDI through the end of June and have a reduced capacity for about a week every three weeks. I believe I can meet the requirements of this position after June, however, I am not at 100% until then.

9. Is there anything in your background that might be deemed as negative or controversial by the Senate?

There was a time early in my career where domestic violence work was considered controversial, maybe even negative - but I am happy to say that is no longer true and thankfully domestic violence advocates are appreciated rather than feared. Even my status as a survivor is valued and appreciated where it was once judged.

I've also been a fierce advocate for LBTQI+ rights because homophobia is rooted in misogyny and gender-based violence against women. I think that is no longer controversial, but I'm including it here, just in case.
