It is a pleasure to support the nomination of Max Otani to the Hawai'i Paroling Authority ("HPA"). In the time that Mr. Otani has served as the interim member of the HPA, the deputy public defenders have found him to be very fair in his adjudication of cases. The HPA is tasked with making very difficult decisions in terms of the assigning of minimum terms of incarceration as well as the granting or denying of parole requests.
