Thank you for this opportunity to strongly support the nomination of Beatrice Kau'i Martinez for the State Council on Mental Health. I have known Ms. Martinez for approximately five years in her current role as Resident Services Program Specialist at the Hawai'i Public Housing Authority (HPHA). Ms. Martinez is an exceptional partner to our program at the Hawai'i State Department of Health (DOH) Tobacco Prevention and Education Program (TPEP). In 2015, the DOH TPEP, DOH Public Health Nursing Branch (PHN), Hawai'i Public Health Institute/ Coalition for a Tobacco-Free Hawai'i, and HPHA collaborated to launch a wellness initiative involving HPHA managers and staff who service over 80 properties throughout the state. (1) Why do you want to be a member of the Board?

I want to be a member of the Board so residents who live in low income public housing, affordable housing, or have housing related issues can have a voice. I want to be part of something that positively impacts the lives of people who suffer from mental illness, their families who support them, to bridge any gaps in mental health services, and to ensure quality services are in place to provide continuity of care for anyone receiving mental health services.

(2) What do you perceive are the roles and responsibilities of a member of the Board?

I perceive the roles and responsibilities of a member of the Board to be an advocate for consumers, to ensure decisions on policies or law being put forth by government bodies positively impact the lives of consumers and their families, to bring public awareness and education on mental health issues, to improve the quality of care and lives of consumers and their families, and to monitor, review and evaluate the mental health services in the state.

(3) Given your understanding of the roles and responsibilities of a Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board.

As a current member of the State Council on Mental Health (SCMH), and having experienced being on the SCMH, I believe I am the right person to fulfill the Housing Representative seat. I believe that I am qualified for this position because I am compassionate, dedicated, caring, empathetic, enjoy serving others and firmly believe that everyone should be treated equally.

As a former employee of the DOH-Adult Mental Health Division I worked closely with providers in the community who provided an array of services to consumers, such as case management, representative payee, homeless outreach and interim case management, family psychoeducation, housing, and transportation. I also assisted with managing the Hawaii Certified Peer Specialist Internship program which was designed to train and equip consumers with the necessary skills to allow them to work with and support other consumers in their journey to recovery.

Being able to manage, coordinate and fulfill my responsibilities daily took being organized, dedicated, detail-orientated, understanding the impact of appropriate mental health services and knowledgeable in the programs I was responsible for. I believe possessing these types of skills will aid me as a member of the Board.

Combined with my current position at the Hawaii Public Housing Authority as a Resident Services Program Specialist in the Property Management Branch, I have a wide range of experiences working with and coordinating supportive services to individuals and families who are in need.

(4) What do you hope to accomplish during your term of service?

During my term of service, I hope to continue with improving access and availability of services for consumers, specifically for individuals and families with housing needs, to increase public awareness and education on mental health services within the State of Hawaii, and to actively participate in the State Council on Mental Health.

(5) Name three qualities that best describe you and how these qualities will benefit the Board.

a. Integrity: I believe in being truthful, honest, and moral. I believe this quality will benefit the Board because it will help me to make ethical and moral decisions that will benefit the consumers and their families within the state. This also means, if something is not right, I would not be afraid to speak up and be that voice of concern and reason to ensure collectively as a Board we are doing what is best for the consumers and their families.

- b. Good Listener: Being a good listener is a quality that will benefit the Board because I have an ability to focus on and hear what the person is saying when they're not saying it, I understand and care about what someone is saying, I'm not afraid to make eye contact and be present while listening, and I am empathetic. This will help to make sound decisions that will benefit the consumers, their families, and the community.
- c. Genuine: I have always been a genuine person and truly care for others and their well-being, no matter their status or station in life. I was raised in a home with a firm foundation in compassionate service to others and was taught to give freely of oneself to anyone in need. This quality has remained with me and has helped me to become the person I am today. I believe the Board will benefit from this quality because it will help to advocate for the consumers and their families because I genuinely care about their quality of life and having programs in place to provide services for their continuity of care and journey in recovery.

(6) Name a previous experience you've had that will be beneficial as a Board member.

In my current position with the Hawaii Public Housing Authority (HPHA), I engage with many residents on the phone or in person (walk-ins) who need assistance or want to make a complaint. Sometimes some residents come more frequent than others.

On one particular morning, a resident of HPHA walked-in (as they have done on many other occasions) and seemed very agitated and frustrated. He came in to make a complaint, and another staff member began to engage him publicly at the front counter. I quickly noticed communication broke down between the two parties (voices were raised) as he kept requesting to speak where his information wasn't heard by everyone. The resident felt he wasn't being understood and got more frustrated. I immediately intervened and asked if he would like to speak with me in our conference room. He gladly followed me complaining the whole way as we walked away from the counter.

After about 5 minutes, he calmed down and began to share with me his diagnosis and struggles he has had living on his own and how his neighbors and some staff treat him because they think he is "crazy" so no one listens to him. I continued to listen and was able to get to the source of his complaint, which was related to this unit. I asked him if he

was alright with me calling the Management office to speak on his behalf. After speaking with the Manager, a work order was issued to address the plumbing issue in his unit.

This experience demonstrated to me how people with mental illness are stigmatized and often not "heard" because of our own fears and misunderstanding. I believe education and awareness of not only mental illness is important, but also how we react to and treat others who may display behaviors related to mental illness. Everyone just wants to be "heard" and understood but sometimes their voice isn't heard. I know being a member of the State Council on Mental Health will give me a greater opportunity to do this on the council and within my agency at the Hawaii Public Housing Authority.

(7) Can you foresee any possible conflicts of interest that could arise during your service on the Board? How would you overcome conflicts of interest?

No, I do not foresee any conflicts of interest. If I had to overcome a conflict of interest, I would address it immediately with the Board Chairperson and the DOH representative and proceed with the necessary course of action.
