I truly have enjoyed working with the current Contractor License Board the past year as interim appointee and hope to participate the next 4 years to work alongside this caring team.

- (1) Why do you want to be a member of the Board?
[I have been licensed as a Contractor since 1993 and believe my experience and knowledge will be a help to the Contractor License Board. I am committed to helping our State to the best of my abilities and feel I can contribute to the Construction industry.](#)
- (2) What do you perceive are the roles and responsibilities of a member of the Board?
[To follow the Rules and Regulations and ensure that Contractor applicants are qualified and continue to follow the Rules and Regulations.
I served on the CLB previously \(2005-2012\) and although the work is very time-consuming, it is rewarding to work with a Board with a common goal.

- (3) In what ways do you feel that you can help protect the consumer?
[I believe there are several ways, but the three most effective \(in my opinion\) is to screen applicants and carefully review qualifications; second to provide clarifications to questions \(by contractors\) on the scope of various projects to match the rules, policies and procedures; and to provide an avenue for consumers to seek clarifications, support and \(possibly\) actions against poor workmanship of licensed contractors.](#)
- (4) Given your understanding of the roles and responsibilities of a Board member, why do you believe that you are qualified for the position? Please include a brief

As a former Board member (2006-2012), I believe the experience and historical familiarity is an asset to the Board. I am able to voice concerns with confidence and (at times) recall past decisions that help expedite decision making.

I believe my background and contracting experience is an asset to the Board.

My roles as a contractor include supervising the work, managing the various teams and have built trust and (I believe) a very good reputation in the industry as a team-player, people-person and knowledgeable manager as a Mechanical Contractor.

I have no agenda other than to provide support to the CLB in whatever way that is possible with my experience. I do appreciate the cohesive and one-mindedness that the Board currently has and hope to continue its success by volunteering my time with the same-mind.
